## **FREQUENTLY ASKED QUESTIONS**

- **HOW IS SAHYOG- CARE FOR YOU DIFFERENT FROM OTHER NGO'S?**

SAHYOG AIMS AT PROVIDING QUALITY EDUCATION TO SLUM CHILDREN. HOWEVER, APART FROM THIS, SAHYOG RUNS MANY PARALLEL PROJECTS SUCH AS PROVIDING CRÈCHE FACILITY IN SLUMS, PROMOTING ENVIRONMENT AWARENESS, ORGANISING HEALTH CAMPS, PROVIDING TRAINING AND EMPLOYMENT TO MEN AND WOMEN LIVING IN SLUMS, HELPING OLD AND DESTITUTE PEOPLE, AND PROVIDING REMEDIAL CLASSES TO CHILDREN STUDYING IN GOVERNMENT SCHOOL.

- **HOW IS SAHYOG- CARE FOR YOU DIFFERENT FROM OTHER NGO'S?**

WE ENSURE THAT CONTRIBUTION MADE BY PEOPLE IS USED IN THE BEST POSSIBLE MANNER. WE USE PEOPLE'S DONATIONS IN PROVIDING STATIONERY, MID-DAY MEALS AND BOOKS TO CHILDREN. WE ALSO USE THESE DONATIONS IN EXTENDING OUR SUPPORT TO MORE CHILDREN BY INCREASING THE NUMBER OF ENROLMENTS AND BY OPENING CENTRES IN OTHER SLUM AREAS.

- **HOW DO YOU ENSURE THAT CHILDREN STUDYING IN YOUR SCHOOL HAVE A GOOD FUTURE?**

AFTER TEACHING THESE CHILDREN FOR A FEW YEARS, WE MAINSTREAM THESE CHILDREN INTO GOVERNMENT SCHOOLS. LAST YEAR, WE MAINSTREAMED 65 STUDENTS IN GOVERNMENT SCHOOLS. EVEN WHEN STUDENTS ARE SENT TO GOVERNMENT SCHOOLS, WE CONTINUE TO SUPPORT THEM AND MONITOR THEIR PROGRESS THROUGH REMEDIAL CLASSES. WE ALSO AIM AT SUPPORTING THESE CHILDREN IN THEIR FUTURE ENDEAVOURS IN EDUCATION AS WELL AS CAREER.

- **HOW LONG DO I HAVE TO SPONSOR THE CHILD I AM SPONSORING?**

IT DEPENDS ON YOU WHETHER YOU WISH TO SPONSOR THE CHILD FOR A MONTH, FOR A YEAR, FOR 2-3 YEARS, FOR 5 YEARS OR TILL THE SPONSORED CHILD FINISHES HIS/HER EDUCATION.
